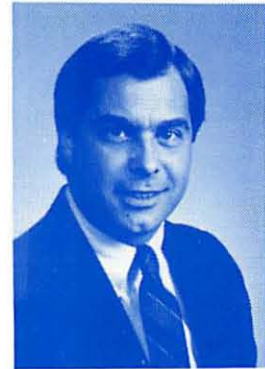

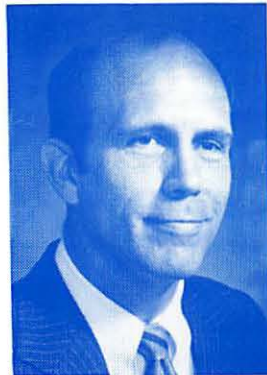

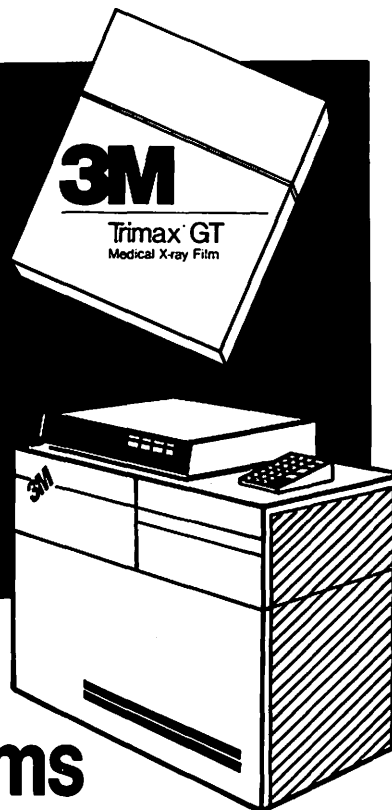

January 17, 1987 Minutes - MSRT Board of Directors

The January 17, 1987 Missouri Society of Radiologic Technologists Board of Directors Meeting was called to order at the University of Missouri Medical Center by President and Chairman, **Michael D. Ward** at 10:30 a.m.

President Ward introduced each member. A quorum was established. President Ward appointed **Barbara Hente** acting secretary.

The minutes of the Pre-convention, Convention and Post Convention, 1986, meetings were approved as prepared and mailed by the secretary, **Lee Ann Ackerman**.

Treasurers Report: **Jennifer Ewert** presented a written report for the first quarter showing total first quarter revenue of \$1,791.96 and expenditures of \$2,787.51. The beginning balance was \$3,006.42 leaving a balance as of 1/

14/87 of \$2,151.28 in the checking account. The balance in the Scholarship account is \$982.92; balance in 6 month CD is \$8,000.00.
Committee Reports:

1. Ways and Means: Chairman **Barbara Hente** presented a written report outlining progress on Scholarship Fund Raffle, RADIO-GRAPHER advertising, Logo/Lapel pins and the 1987 Annual Meeting funding.

2. Scholarship Fund: A verbal report was given by President Ward. Michael had spoken with Chairman Pam Fulmer prior to his leaving for this meeting. There will be some revision of the Scholarship Fund application form. The requirement to enclose a photograph (even though a photo is "optional") will be removed. There will be clarification as to how the scholarship money will be issued to the institution/student.

3. Membership: Chairman Cindy Daniels was not present. President Ward presented a written report from Chairman Daniels. Cindy has prepared a rough draft of a flyer and requested comments/suggestions regarding the draft. Discussion followed. **Roy Jerden** has a listing of the hospitals in Missouri and he will copy this list and forward copies to Cindy, President Ward and Barbara Hente. Suggestions were to add continuing education, "who the MSRT is", identify who C. Daniels is, etc. Jennifer reminded us that Ruby Givens had suggested a membership drive with a prize for who recruited the most members. A copy of a recruitment brochure from the Iowa Society of Radiologic Technologists was given to President Ward by Barbara Hente for Cindy to review. A suggestion was made by **John Bryan** for the membership chairman to outline recruitment goals for an on-going basis with the possible long term goal of having a marketing committee to incorporate recruitment, public relations, membership, etc. for cohesiveness of efforts.

Motion #1: I move that a standing committee be formed which shall be known as the Planning Committee and shall consist of the President, Past-President and President-Elect whose duties shall be decided by the Board, but whose charge shall be to formulate short and long range goals and objectives for the benefit of the Society and report such goals to the Board for consideration and approval at the July MSRT Board meeting. Moved by R.B. Jerden, Second by P. Mueller. Motion carried.

4: Nominating Committee: Chairman Kathy Parsons has just had surgery and could not be present. Kathy had communicated with **Jennifer Ewert** (Nominating Chair 1986) and Jennifer presented a verbal report from Kathy. Jennifer has formulated notes on the Nominating Committee duties which will be sent to Pam Fulmer for inclusion in the Board of Directors manual updates. It is encouraged that biographical information be sent with the voting ballots as well as be published in a MSRT publication.

District Representatives Reports:

Four: **Roy Jerden** presented a written report. Roy outlined the fall 1986 meetings and the upcoming February meeting, as well as plans for a seminar in May.

Five: A verbal report was given by Vice-President **Nikki Thielmann** in the absence of Fifth District Representative Dan Cantrell. Nikki noted that a free standing MRI unit opened in Springfield, Mo. in January, 1987.

Three: House of Delegates Affiliate Representative **Jim Watson** reported that members of the district are trying to get a meeting together for January. Jim reported that Judy Taylor is working very hard to get the district together.

Six: Michael will continue to assist Lisa Brouwer and Rita Montgomery with information and support.

One: Information from Pam was that a meeting was held with 9 RT's and 5 students attending. The topic was licensure. Tony Bennet, student at St. Lukes in Kansas City researched the topic and provided information.

ASRT Affiliate Delegates to the House of Delegates: Michael has received the new handbook. Barbara Hente received the new handbook and passed it on to newly elected delegate Jim Watson.

Regional V Regional Director Delegate Report: **Norman L. Hente** reported that he is getting communication from the ASRT Board of Directors. He provided an update on the Region V meetings.

RADIOGRAPHER: Editor **Barbara Hente** presented a written report. Jennifer reported a new mailing address of: Rt. 3, Box 480, West Plains, Mo., 65775. She also reported that she 'appears' to still be in District 5.

Ulysses D. Murray Lecture: President Ward has been in contact with Mr. Murray for his thoughts and input on a person to invite to be the lecturer. Michael has a listing of several names. Mr. Murray indicated that he would like Beth Anderhub to be the first lecturer. President Ward will contact Beth with the request.

Computer Report: **Barbara Hente** presented a written report concerning what the computer has been used for and included copies of various sheets of data. A new membership form has been designed and comments were requested.

Recess for lunch at 1:00 pm. Reconvene at 2:20 p.m.

1986 Convention Report: **James Watson**, 1986 Annual Meeting Chairman presented a

written report. His financial statement was amended to include transactions from the MSRT Treasury. A check for \$327.22 was written to the University of Missouri to cover their loss involved. After recalculation and inclusion of the MSRT treasury expenditures the total net loss is \$582.86. Consensus of the Board was that we not use the services of UMC again.

1987 Convention Report: **Roy Jerden** presented a written program report prepared by Co-Chairmen Lee Ann Ackerman and Eileen FitzGibbon. Roy is general program chairman. Several comments were made including that the program was very well put together and the Board was pleased with the number of educational time slots that were already filled. Comments were made regarding the hours of available educational activities, amount of free time and location of free time slots, etc. Roy will report to the Convention Co-Chairmen for their information.

Correspondence: The following items were reported by President Ward:

--a letter from Region V Nuclear Medicine Modality Representative JoAnn Horsfield. She asked to be put on our mailing list for our publications. She reported that Iowa (effective January 1, 1987) has a "Permit to Practice" law. This does not include those technologists doing Nuclear Medicine exclusively. Also, effective July 1, 1987 all technologists doing radiographs have to show proof of continuing education (12 hours/year or 24 hours/2 years). If any Missouri technologists working in Iowa need further information they should contact JoAnn. She thanked President Ward for the invitation to attend the MSRT Board of Directors meeting.

--a letter from Kansas President Tom Long expressing concern to keep Region V affiliated informed of what "each other is doing". He is

interested in improving the strength of Region V within the ASRT structure. Tom asks other Region V Presidents to correspond regarding a regional meeting at or prior to the 1987 ASRT meeting.

--note regarding the removal of Charles Fugger from all MSRT mailing lists. Mrs. Fugger informed President Ward that Mr. Fugger is deceased.

--letter forwarded to President Ward, via Ruby Givens, from the Missouri Association of Osteopathic Physicians and Surgeons regarding a request for donations to the Scholarship Fund. They do not have this funding on their budget.

--letter regarding Cox Medical Center (Springfield, Mo.) poster contest for National Radiologic Technology Week. Michael wrote letters of congratulations to the winners of the poster contest and the administrator at Cox. Nikki reported the letters from President Ward were well received.

--letter from Judy Taylor declining the chairmanship of the Student Advisory Committee due to other commitments.

--letter from Ward Keller asking for 1987 meeting dates, new life members, selected lecturer, etc. for publication in the ASRT Scanner. Roy Jerden will send information to the ASRT for inclusion in their Journal. Michael will forward Scanner information.

--letter from Susan Towne, RT from Kirksville regarding information on how to become involved in the MSRT. This letter and other information was referred to John Bryan to contact Susan as John is in the Kirksville area several times a week.

--letter from Judy Taylor regarding the need for MSRT membership labels. This was referred to Barbara Hente who will sort and send a list

and set of labels to Judy.

--letter from Lynn Rhatigan of Beth Israel Hospital in Passaic, N.J. seeking technologists for employment. This was referred to Editor Hente for inclusion in the next publication.

--letter from Marilyn Chapman, ASRT House of Delegates Kansas Delegate, regarding switching their fall symposium and spring convention. She asked for general feelings about spring vs. fall conventions.

--letter from Rita Montgomery regarding ARCRT supervisors for new correctional facility - the employment ads request ARCRT registered applicants. She further reported that ARCRT registrants are using "RT". She asked for information and possible flyer on the differences between ARCRT and ARRT training, education, philosophy, etc. She included an ARCRT membership form and other papers.

--President Ward requested that any correspondence between Board of Directors members or committees be copied to him as President.

Unfinished Business: The motion tabled at the Post-convention Board of Directors meeting was brought from the table. Motion was defeated. President Ward noted that the lease to purchase agreement will be signed as soon as possible. The first two installment payments were made at this meeting. Hearing no new business, President Ward announced that the date for the next Board of Directors meeting will be April 11, 1987, location to be announced.

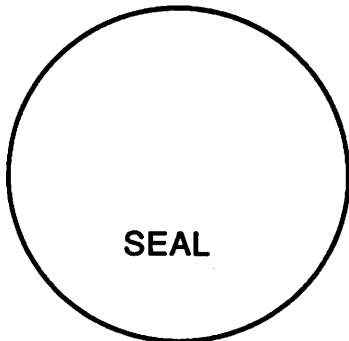
WHEREAS, October 4-10, 1987 has been designated Missouri Radiologic Technology Week; and

IN MEMORIAM

It is with deep sorrow that the Missouri Society of Radiologic Technologists must report the death of Mr. Robert A. Feldhaus on September 4, 1987.

Bob supported his professional societies since his 1960 graduation from Alexian Brothers Hospital School of X-Ray Technology in St. Louis. His first membership was with the St. Louis Society of X-Ray Technicians (later to become Fourth District, MSRT). While he held various offices on the local level, he is best remembered for his "always being there" when someone was needed to work on a committee or "take care of details". He was awarded Life Membership in the Fourth District in 1986.

At the time of his death Bob was, again, the Public Relations Committee Chair for the MSRT, a position that he held so often it had become second nature. DUES INCREASE PROPOSED --- LAST INCREASE IN 1979!

share in the Region V funding of the Regional Modality Delegates. This adds another \$400

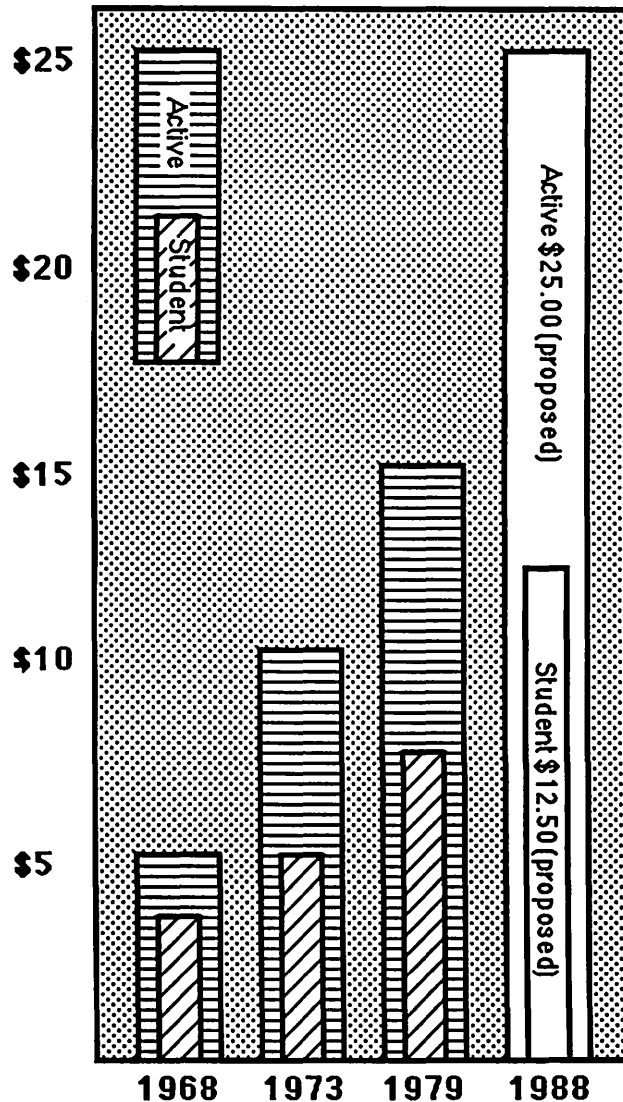
to our expense budget each year. **COMPUTERIZATION OF THE MSRT**

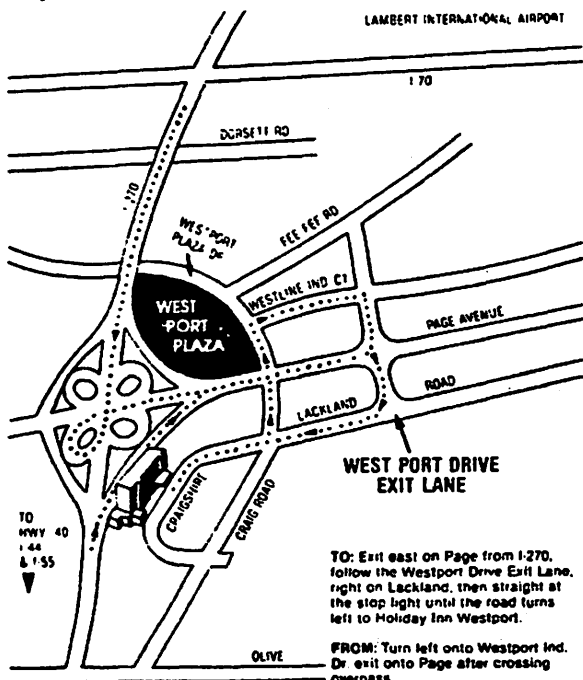
